FOOD & BEVERAGE GUIDELINES – PER STATE OF OHIO LAW

In compliance with Ohio State Liquor License Law and Health Department regulations, please be aware of the following guidelines:

- **No outside food or beverages** are permitted on Pinnacle property. This includes food or beverages for distribution or service.
- **Alcoholic beverages** not purchased from Pinnacle Golf Club/ Cimi's Bistro (the licensed holder) will be confiscated and discarded as required by Ohio law.
- Any event participant found violating Ohio's liquor laws will be asked to leave the property immediately, and no refunds will be issued.
- Violating Ohio liquor laws may also result in fines or prosecution.

It is the responsibility of the event host/ sponsor to inform all participants and guests of these regulations. For any clarifications, please contact your Pinnacle Event Coordinator to ensure compliance with all state laws.

GOLF OUTING DAYS & TIMES

Pinnacle Golf Club hosts outings on Mondays, with shotgun start times beginning at 11:00 AM. Please note the following player limits and fees:

- **Minimum golfer billing:** 72 golfers
- **Maximum golfer billing:** 136 golfers

Pinnacle Golf Club has sufficient golf carts to accommodate 136 players, plus a few additional carts for event hosts to use for photography, raffle ticket sales, etc. Should your event require additional golf carts, they can be rented for an extra fee, which will be added to the final invoice. Please inquire about costs and provide a 90-day advance notice if additional carts are required.

- **Golf Fee per golfer: \$105.00**
This fee includes golf, shared cart, practice range access before the shotgun start, and all tournament services listed earlier in this document.

Food and beverage packages are **not** included in the per-golfer fee. Consult with your Pinnacle Event Coordinator to review available food and beverage packages and associated costs. In accordance with Ohio state law, all food and beverages must be purchased directly from Pinnacle Golf Club.

OPTIONAL SERVICES & FEES

- Two (2) on-course comfort station attendants: \$100.00
- Rolling beverage cooler setup at registration/ turn area: \$50.00 per bin
- On-course table & chair setup (includes linen): \$25.00 each
- Table linens and napkins for post-golf banquet: \$25.00 per table
- Coffee station at registration: \$30.00 per gallon
- Bloody Mary bar at registration: Please inquire

Event Enhancements:

- Optional drink tickets (per golfer): Please inquire
- Pro Shop prizes & gift certificates: Please inquire

FOOD & BEVERAGE CUSTOMIZATION

GOLF OUTING AGREEMENT

This agreement is entered into on the _____ day of _____, 2025, between Pinnacle Golf Club (hereafter referred to as "Pinnacle") located at 1500 Pinnacle Club Drive, Grove City, Ohio 43123, and _____ (hereafter referred to as "Sponsor").

In consideration of the mutual promises set forth in this Agreement, the parties agree to the following:

Event Date

The Sponsor agrees to hold the event at Pinnacle Golf Club on _____, 2025. No alternate or rainout dates will be accepted.

Liabilities and Responsibilities of the Sponsor

1. The Sponsor assumes full responsibility for any damage to Pinnacle Golf Club's grounds, equipment, or property caused by the Sponsor or their guests/participants during the event.
2. The Sponsor shall designate a representative to communicate with participants that they are responsible for any damages incurred. Damage to Pinnacle's property, including but not limited to golf carts, the golf course, and other facilities, will be billed to the Sponsor and their representative.
3. The Sponsor agrees to indemnify and hold Pinnacle Golf Club harmless from any and all claims, actions, damages, liability, and expenses arising from personal injury, or property damage attributable to the Sponsor or their guests.
4. Unless otherwise agreed in writing, Sponsor and guests shall confine their use of Pinnacle's facilities to the golf course and clubhouse.
5. The Sponsor understands and acknowledges that, in accordance with Ohio State Liquor License Laws and Health Department regulations, no outside food or beverages are permitted on Pinnacle property. This includes any items intended for distribution or service. Alcoholic beverages not purchased from Pinnacle Golf Club/ Cimi's Bistro (the licensed holder) will be confiscated and discarded, as required by Ohio law. Any participant found violating these liquor laws will be asked to leave the property immediately, without refund. Additionally, violations may result in fines or prosecution. It is the responsibility of the Sponsor to ensure that all event participants and guests are informed of these regulations. For any clarifications, the Sponsor should contact Pinnacle's Event Coordinators to ensure full compliance with state laws.

Guarantees & Billing

1. All food, beverage arrangements, and a guaranteed headcount must be finalized at least seven (7) days prior to the event. This guaranteed headcount is the minimum number that will be invoiced.
2. The minimum golfer billing to host an outing at our venue is \$7,560.00, which is based on a rate of \$105.00 per golfer at 72 golfers. This amount will apply even if the actual number of golfers are fewer than 72.
3. A complete list of golf outing participants must be provided to the Pro Shop by the Friday before the event.
4. Invoices will be generated on the date of the event, and payment is due within 15 days (NET 15). Late payments are subject to a 1.50% monthly interest fee and a \$35.00 monthly late fee.

Non-Optional Expenses & Procedures

- All golf outings events will follow a Shotgun Start Format (unless otherwise noted), with start times no earlier than 11:00 a.m.
- The format for all events will be Team Scramble with the Par is Your Friend format (unless otherwise noted).

- All Par 3 holes must be played from the artificial turf tees, regardless of any outside "Hole-in-One" insurance requirements. Pinnacle has four (4) Par 3 holes. All Par 3 holes are also CART PATH ONLY. There will be NO EXCEPTION to this rule.
- All rules and regulations established by Pinnacle regarding the use of golf carts, including traffic patterns and golf course usage shall be strictly enforced.
- A **non-refundable deposit** of \$2,500.00 is required to secure the event date. This deposit must accompany the signed contract and will be applied to the final invoice.
- The event shall accommodate between 72 and 136 participants. The minimum golf billing will be based on 72 participants.
- The Pinnacle GM and Golf Course Superintendent will make all final decisions regarding practice range use, cart path-only rules, or course closure due to inclement weather.
- The Sponsor is responsible for removing all event-related signage, banners, equipment, and supplies at the conclusion of the event. Pinnacle is not liable for any items before, during, or after the event.
- Pinnacle's golf cart fleet includes 68 carts. If additional carts are required, the Sponsor must provide a minimum 90 days' notice, and any additional cart rental costs will be borne by the Sponsor.

This Agreement shall be binding upon the parties hereto. In witness whereof, the parties have executed this Agreement as of the day and year first written above.

The 2025 Golf Outing fees include green fees, up to sixty-eight (68) golf cart rentals, access to the locker room before, during, and up to one (1) hour after the outing, use of the practice range one (1) hour prior to the outing (off artificial turf tees), professional tournament services, tournament scoring, and a prize and place summary.

PLEASE NOTE THAT PRICES FOR FOOD AND BEVERAGES ARE BASED ON MENU SELECTIONS AND ARE NOT INCLUDED IN THE PER PERSON GOLF OUTING FEE.

THERE WILL BE A 22% SERVICE CHARGE ON FOOD & BEVERAGES AND A 7.5% SALES TAX ADDED TO THE ENTIRE FINAL INVOICE.
